Geneeskundige Raad Verskiesings

Ek is oortuig daarvan dat ons steeds verseker kan wees dat ons vertoë onbevooroordeeld aangehoor sal word, want so hoort dit!

Call for innovative training

In an attempt to improve the postgraduated training of the family physician the Academy will have to make the most of the tried and trusted methods but also not hesitate to be innovative. The creation of a cell system throughout the Republic will be a project that should combine both of these criteria.

We have always known that teaching is more effective in the small group. We also know that unless meetings are held by people with similar interests the lectures and other forms of instruction are inclined to become to general and eventually vague.

What is thus needed is that people with the same requirements for good medical practice should set up small cells to which the Academy can

relate. These units can differ in number but must have a convener to coordinate efforts and to spell out the objectives directly to the central body.

Regular meetings can be organised and the venue need not be a problem because catering for large groups is not envisaged.

Methods to teach in these small groups are being examined by the Academy at the moment and video programs are being shown throughout the country. Feed back is essential because we have no unyielding approach to keeping the GP up to date.

It is essential that you begin to set up cells and inform us of their existence so that direct contact can be made.
